

## Emergency Relief Fund Reporting Emergency Financial Aid Grants to Students

1. On **April 9, 2020**, **THE TEMPLE: A Paul Mitchell Partner School** signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.
2. **THE TEMPLE: A Paul Mitchell Partner School** received **\$264,420.00** from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Student.
3. **THE TEMPLE: A Paul Mitchell Partner School** distributed the following amount of Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act;
  - On **May 27, 2020**, **\$264,420.00** was distributed to approximately **271** students as Emergency Financial Aid Grants under Section 18004(a)(1) of the CARES Act.
4. **271** students have received an Emergency Financial Aid Grant to students, each grant being **\$975.72** under Section 18004(a)(1) of the CARES Act.
5. Attached to this announcement is a copy of THE TEMPLE: A Paul Mitchell Partner School's "Grant Disbursement Policy" and a copy of the Student Agreement every grant recipient agreed to for the CARES Act Emergency Financial Aid Grants.

## Grant Disbursement Policy

**THE TEMPLE: A Paul Mitchell Partner School** identified three GROUPS for the distribution of the CARES Act Emergency Financial Aid Grants to Students (“Grants”).

Grants will be in the amount equal to taking the total grant and dividing it by all “eligible” students as determined by the groups listed below.

**GROUP 01:** Every actively attending student (enrolled and not on leave of absence) has incurred an equal amount of “need” in the process of transitioning from face to face education to distance education. Therefore, students meeting this category will automatically be eligible.

**GROUP 02:** Since the Department has clarified that this grant must be utilized for the purposes of offsetting expenses brought on by COVID-19 forcing students to move to distance education. Both the spirit of the program and the guidance from the Department makes it clear that a student **MUST** be actively participating in education for this to happen. By definition, leave of absence students are **NOT** participating. Therefore, any student currently on leave of absence must submit a grant application. This application must clarify how COVID-19 has impacted their studies, and how this grant will allow them to return to their studies. Since the grant must be used to facilitate their education, if they are not actually participating in education, THE TEMPLE will need to understand how they feel they should still get this grant in order to ensure it is properly distributed under DOE guidance.

**GROUP 03:** Students who are starting in this week’s CORE start. Students who are only participating exclusively in distance education are not “eligible”. However, THE TEMPLE determined that these students **ORIGINALLY** contracted for face to face training and only recently agreed to a new contract for distance. Like our existing students, these students will experience a need based on this change. These students will be treated like **GROUP 01**.

### **IMPORTANT**

**The date of determination for grant eligibility will be April 29, 2020.  
Any student who has not started by that date will not be eligible for the grant.**
